Values and Priorities

Councils are not all the same. Some seem to achieve more than others.

Dartford Borough Council is relatively small compared with many neighbouring local authorities but our proximity to London means we have got used to handling substantial pressures - particularly from development and traffic.

Our response has been to focus relentlessly on common-sense and the 'resident voice', using it to guide our decision making. Over the years, it has meant that we have delivered more community facilities and great public spaces, more services guided entirely by resident-choice (like weekly bin collections) and lots of events and policies designed to knit our growing community together. Our council tax has been frozen more times than almost any other council in the country too!

One of our constant frustrations is that we are not responsible for half the things people assume we are. Many aspects of our world - like housing numbers, development regulations and even the need to get started on the Lower Thames Crossing are decisions taken by others. We could stand back and allow all these impacts to pass without much comment (and sometimes protest) but that wouldn't be a reflection of who we are. So, we tend to be outspoken and innovative - gaining a reputation for standing out from other councils. We don't mind that. There are worse things for a local council to be than active on behalf of local people.

All this means that our values and priorities are really important.

We're not really interested in what other councils do - we want to take common-sense decisions on behalf of our borough and the people who live and work here.

Housing

Put simply, we want everyone to have safe, affordable housing.

Of course, that's easier said than done when housing is in short supply all over Britain. Here in the south rents can be especially high and purchasing a property can seem out of reach for many but especially those trying to take the first step on the housing ladder.

Everyone seems to agree that more homes are needed but, let's face it, building them is not always popular with existing communities. It's a big challenge for a council like ours and there are few easy solutions. Despite that, we're determined to make a difference and help as many people as possible, particularly established Dartford families and their children, enjoy safe and decent housing.

Some of our key ambitions include providing more of our own housing stock - rekindling the council house tradition that served our country's housing need well in the past, influencing the condition of homes in the Private Rented Sector and driving up the fairness and transparency of service charges levied by management companies on new private estates. We will also unashamedly prioritise the housing need of established Dartford families and their children.

Building Communities



Our ambitions

- Ensure that our homes are well maintained and empower tenants to shape and influence their own communities
- Relieve homelessness in our town, work to eradicate the causes of it and end rough sleeping
- Encourage well-designed new housing that offers a genuine mix of tenure, style and affordability
- Continue to intervene directly in the affordable housing sector by rekindling the tradition of building Council Houses for the benefit of local people
- Support a strong, high quality, private rented sector by driving up standards and cracking down on bad landlords and ensuring those residents paying private management fees are treated fairly
- Provide a high quality and responsive housing service that's built on respect for aspiring and existing tenants. We want to be practical, honest and straightforward in all the information and advice we give

- To use planning powers to control new housing development and create sustainable places where the closeness of community facilities like schools, shops, leisure, public transport and recreation minimises the use of vehicles and allows people to live as part of a healthy, sustainable community. We will consider the availability of infrastructure such as schools, doctors, transport improvements and green spaces when considering any new development proposal
- In a planning system dominated by national policies and rules, we will nevertheless use the powers we do have to protect and enhance the interests of local communities
- Support flexible, life-time homes and develop planning policies which help build stable communities suitable for all types of families and every stage of life



- Develop pragmatic plans which respond to the views of Tenant Satisfaction Surveys and communicate openly with tenants and leaseholders about our proposals
- Support new affordable housing for sale and rent with our housing association partners
- Actively pursue opportunities to increase our stock of affordable council housing through new build and purchases
- Deliver a revised Private Sector Renewal
 Strategy to help improve housing conditions
- Continue to actively promote grants for disabled adaptations, home improvements, energy efficiency and to decrease fuel poverty in the private sector
- Maintain a housing register of those in housing need to enable them to access good quality affordable homes when it becomes available
- Test planning applications for new housing development against our adopted Local Plan ensuring new builds meet our standards, that larger sites provide affordable housing and that a mix of house types and sizes is provided to create real communities
- Ensure that new housing development provides appropriate open space and responds to the requirements from partners responsible for infrastructure such as new schools, transport improvements and health facilities

- Resist planning permission for windfall housing sites that aren't identified in our local plan unless there is a clear benefit to the local community
- ✓ Give clear and straightforward advice on how to apply for Universal Credit/Housing Benefit/ Disability Benefits. To process claims as quickly and efficiently as possible and ensure residents are receiving the support to which they are entitled
- To continue working with experienced and empathetic partners to tackle homelessness and end rough-sleeping
- To use responsibly the laws and regulations available to us to increase the safety of housing and the health of residents
- Carry out housing repairs to our stock to a good standard and meet or exceed the Decent Homes Standard
- Maintain a robust Local Plan to identify where housing is appropriate and where it is not

We will work robustly with relevant authorities such as Highways England and KCC to lobby for infrastructure and solutions which positively impact the daily lives of our residents and keep our town moving.

Fastrack



- Continue campaigning regionally and nationally for the basic right of residents to enjoy a fully operational road network
- To encourage the adoption of more sustainable methods of transport through the provision of reliable alternatives
- Support an enlightened and realistic approach to transport integration in order to minimise traffic impacts. Work with partners to encourage uptake of sustainable travel and manage the impact of vehicular travel on the strategic and local road network
- Continue focusing on the re-use of previously developed land, rather than increasing the footprint of the built environment, and maximising Fastrack routes and other existing good connections to public transport, services and infrastructure, particularly in the north of the Borough
- Support alternatives to the private car to enable people to choose to lessen their reliance on private vehicles, particularly at peak times, in order to reduce congestion

- Support a range of upgrades to the transport network, and a choice of sustainable and active travel options, with rapid and reliable public transport linking existing neighbourhoods and new developments to key destinations and facilities, together with a high quality and comprehensive walking and cycling network
- To achieve the upgrade and delivery of modern public transport facilities, and better interchanges
- ✓ To ensure cycling, walking and pedestrian routes are safe and well-lit
- Reduce the impact of traffic on air quality, both traffic passing through and generated within the borough.'



- Advocate strongly at regional and national level for the Lower Thames Crossing to relieve pressures on the M25 and local roads
- Continue developing strong working relationships with Kent County Council (as the local highways authority) and Highways England to lobby for improvements such as Junction 1a on M25 and other strategic measures to improve the road network
- To maintain a common-sense approach to encouraging sustainable methods of transport, recognising that adopting measures hostile to motorists is counter-productive. We will encourage modal shift through the delivery of attractive and viable alternatives to the private vehicle
- ✓ Create a more sustainable taxi fleet
- Adopt the Local Cycling and Walking Infrastructure Plan for Dartford and ensure this is implemented through new developments in partnership with KCC as highway authority supported by CIL funding where necessary
- Expand and refresh partnership working to support delivery of enhanced Fastrack services
- Support the implementation of the Fastrack tunnel between Bluewater and Ebbsfleet and require the opening of the Fastrack route through Ebbsfleet Valley as soon as possible

- Work with partners for options to improve Fastrack priority through key junctions to improve journey reliability when there is traffic congestion and support KCC in the roll out of electrical buses for the Fastrack service
- Deliver secure cycle parking in new developments
- Continue to advocate for improvements to Dartford railway station and stations across the Borough
- Continue to consult and implement the Dartford Town Centre Parking Study to ensure commuter parking is directed away from local residential roads
- Encourage the use of the rivers for the sustainable transport of goods and passengers as part of proposals for strategic scale development
- Encourage a stronger Dartford town centre economy and the use of local retail, employment and leisure facilities to reduce the length of trips by private car


We will focus on tackling crime, disorder anti-social and illegal behaviour through our own services and will demand other statutory partners and public services to do the same.

- Utilise the tools and powers available to the council to tackle anti-social behavior (ASB)
- Help communities to feel safe by improving public perception of safety and reducing the fear of crime
- Reduce crime and disorder including violence against women and girls
- Set a high quality safety and health standard for businesses in Dartford Borough and assist businesses in meeting those requirements.
- Promote personal safety and reduce crime committed in Dartford businesses
- Operate safe and compliant spaces and events within the borough
- Carry out robust enforcement of littering, antisocial driving and fly-tipping offences
- Remove graffiti and other evidence of ASB quickly

- New buildings and spaces should be designed to avoid providing opportunities for crime
- Grow the mid-evening economy, particularly in the town centre: through diversified uses and activities, family friendly activities to be encouraged and supported in the town centre and district centres
- Residents and businesses are proud of the town centre and public places in the Borough and frequent them regularly so that the streets and spaces are well-used by law abiding people rather than freeing them up for anti-social behaviour to take place



- New developments should all be required to provide adequate lighting along new streets, within car parking areas and along key walking routes. Opportunities will be taken to upgrade lighting wherever possible through legacy developments in the Town Centre and elsewhere. Lobby KCC over replacement of street lighting with LED units
- New developments required to be designed to provide visual policing of streets and spaces and design out crime
- Enforcement of car parking controls to reinforce message to community that the Council will support enforcement of rules and care about the streets
- Maintain quality of environment, street cleaning and fly-tipping removal
- Maintain landscaping to ensure there are views along paths and footways are clear minimising hiding places and the perception of a poor environment
- Provide Licensing, Environmental Health and Safety services that support businesses to deliver high safe services in the borough
- To continue to make use of Community Protection Warnings/Notices and Public Spaces Protections Orders to reduce the detrimental impact that anti-social behaviour (ASB) can have on local people/communities

- To continue to take a leading role in the Community Safety Partnership, as part of the council's statutory responsibility to ensure that all statutory partners are working together to do all they can to reduce crime, disorder and ASB in Dartford
- To continue to make use of CCTV and evidence-gathering technology to improve public safety in and around the Town Centre whilst assisting partners such as the Police by producing evidence in order to bring offenders to justice
- Act promptly to reports from the public to the Council where non-compliance or crime occurs in Dartford businesses. This includes issuing litter Fixed Penalty Charge Notices, enforcement activities and the removal of graffiti and fly-tipping
- Increasing DBC enforcement officers visibility in Dartford (review of Kingdom access areas and introduction of Town Centre Managers)

Public Health



- We will consider the health impacts of everything we do to ensure our actions positively impact the health of Dartford's population
- ✓ To understand the type and causes of health inequalities in Dartford
- Create a Dementia Friendly Community, increasing awareness and understanding of dementia and of people living with dementia
- Create a practical strategy to improve the health and wellbeing of residents aged 50+ and reduce health inequalities
- Improving health and wellbeing, and air quality arising from congestion, through reducing the need to travel by private vehicle, particularly by retaining and providing jobs, services, shops, community facilities and open space at suitable locations close to residential areas and where good public transport services are within easy walking distance
- Protect and enhance existing green spaces whilst encouraging improved walking environments and sporting facilities
- Continue efforts to reduce pollution across the borough and promote better air quality

- We will underpin all DBC policies with an understanding of the interconnected social determinants that impact Dartford residents health and wellbeing; economy, employment, education and learning, leisure and physical activity, green space, pollution, crime and personal safety, social cohesion, volunteering, governance

- We will work closely with Primary and Secondary Health Care Providers to better understand what services are not being accessed and why and co-design and implement solutions that promote equality in health outcomes for Dartford's residents such as Falls Prevention and accessing diagnostic and mental health services
- Delivery of an Air Quality Action Plan
- To provide and improve childrens' playgrounds, skate parks and outdoor fitness gyms across the borough and demand the provision of new open spaces in new developments
- Provide a subsidised Pest Control Service for those in need



- To encourage a more responsible approach to consumption of resources and the management of waste
- Support the shift towards cleaner modes of transport with benefits to air quality and health
- Protect, enhance and increase green space for the benefit of people, wildlife and effective sequestration of carbon
- Increase biodiversity and encourage sustainable development and lifestyles
- Support the generation of renewable energy across the Borough
- Support decarbonisation in businesses, homes and the council's own properties
- Empower residents, businesses and communities to make informed decisions on climate change and access relevant grants
- Ensure the Borough is able to adapt to the effects of climate change and contributes towards reducing Dartford's carbon footprint through an increase in the proportion of water efficient buildings, the uptake of domestic and small scale renewable energy, and promoting environmental resilience, new greenspace and tree planting
- Prioritise path to a Net Zero Carbon future

- Promote sustainable local environments and habitats, achieving biodiversity net gain and active and healthy living, at new developments and through greenspace (including urban parks and open space) and landscape protection and provision, enhancing the green grid of footpaths, public rights of way, cycle routes, wildlife corridors, rivers and countryside links
- Existing green spaces, habitats, and tree coverage will be protected and enhanced, and new provision will be made, to absorb carbon dioxide, support biodiversity and reduce surface water runoff
- Protect good quality trees which contribute to the green environment and also absorb CO2 and provide urban cooling and plant new trees and landscaping where appropriate and opportunities arise
- ✓ The design, location and construction of development will: minimise energy consumption; regulate internal temperatures; provide appropriate natural shading on buildings, at street level and in open spaces; incorporate renewable or low/ zero carbon energy sources; and allow for other new sustainable technologies to be provided or readily incorporated in the future



- To increase the number of orchards and wildflower meadows across the borough
- To implement a service for the separate collection of food waste
- ✓ To develop the effectiveness of the street cleaning service
- Work with partners to support public transport use and improvements to infrastructure
- Support active travel in the Borough via the development of the Local Cycling and Walking Infrastructure Plan for Dartford.
- Produce a DBC EV Strategy and improve the network of EV Charge Points in the Borough
- Continue to signpost and promote energy efficiency schemes and grants to help businesses and residents decarbonise
- Continue to champion more sustainable development through the Local Plan
- Implement the DBC Air Quality Action Plan monitor air quality and proactively support initiatives to reduce air pollution (e.g. anti-car idling campaigns and 'school streets' where school roads are closed to traffic at pick up and drop off times)
- Continue to support residents and businesses to reduce energy consumption and increase renewable energy purchase and generation via Solar Together scheme and Kent Energy Deal

- Improve the percentage of household waste reduced, recycled and composted
- Improve access to open space, food growing and wildlife through land management, community gardening and habitat creation
- Ensure planning policy protects urban open spaces and green infrastructure from development and maintains a Green Belt from inappropriate development
- Water efficiency: require all houses (via planning policy) to deliver the improved water efficiency of 110 litres per day to be secured through building regulations
- New development required to mitigate climate change through compliance with Local Plan and national policy
- Use of Tree Preservation Orders to protect trees where appropriate
- Enhance bio-diversity where new development takes place, on-site where possible or where more appropriate off-site to enhance habitats
- Require new developments to plant appropriate trees and landscaping through Local Plan policy
- Enhance the environment around the Rivers Thames and Darent whilst maintaining their flood and ecological functions of the land adjacent


