INTRODUCTION

This profile summarises a range of population data for the Dartford Town area in Dartford Borough. The area consists of the wards of Brent, Bridge, Burnham, Heath, Princes, Newtown, Temple Hill, Town and West Hill. A small part of the Princes ward, around Brooklands, is covered by Wilmington Parish Council.

As the ward boundaries changed in 2019, direct comparisons to earlier time periods should not be made.

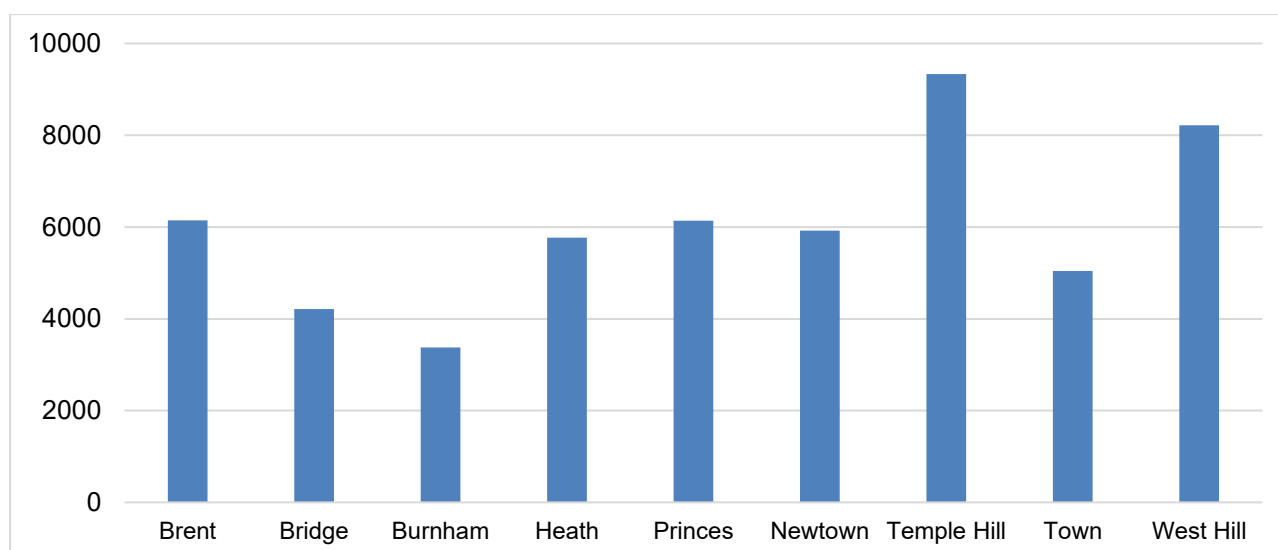
SUMMARY

- Dartford Town has a relatively young population, with the proportion aged under 25 years old being 32.8% compared to the Borough average of 31.2%.
- The most populated wards within Dartford Town are Temple Hill and West Hill. However, population density is highest in Newtown at 72.2 persons per hectare, against the overall Borough density of 16.1.
- The area is diverse with ethnic minority groups making up 32.6% of the population, higher than the Borough average at 25.5%.
- Terraced properties and purpose-built flats are most common, representing 36.4% and 22.5% of housing stock respectively. Just over 65% of dwellings are owner occupied.
- Unemployment is higher in Dartford Town (3.8%) than the averages of the Borough (3.1%) and Kent (3.4%).
- Town and Temple Hill have the lowest levels of car ownership of all wards in the Borough. Respectively, 26.8% and 30.3% of households do not own a car or van.

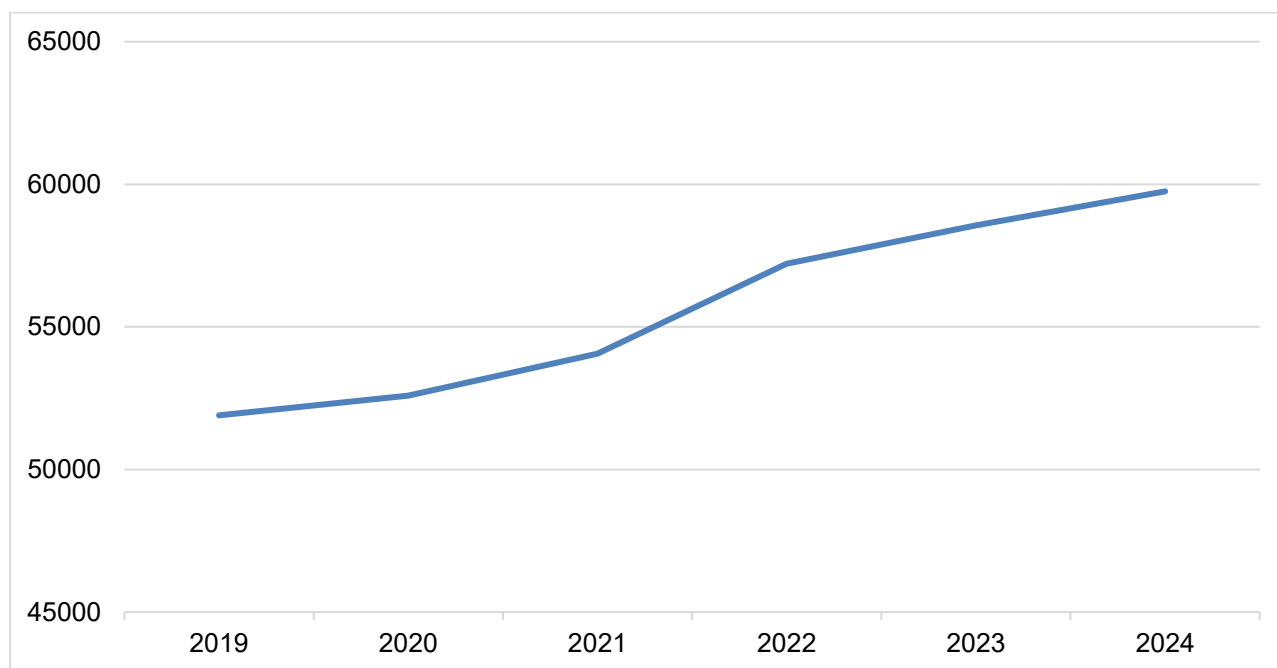
POPULATION

In 2021, Dartford Town had a population of 54,161 people. This comprised of 26,518 males and 27,643 females, representing a 49% and 51% split respectively.

Chart 1: Population by ward within Dartford Town, 2021

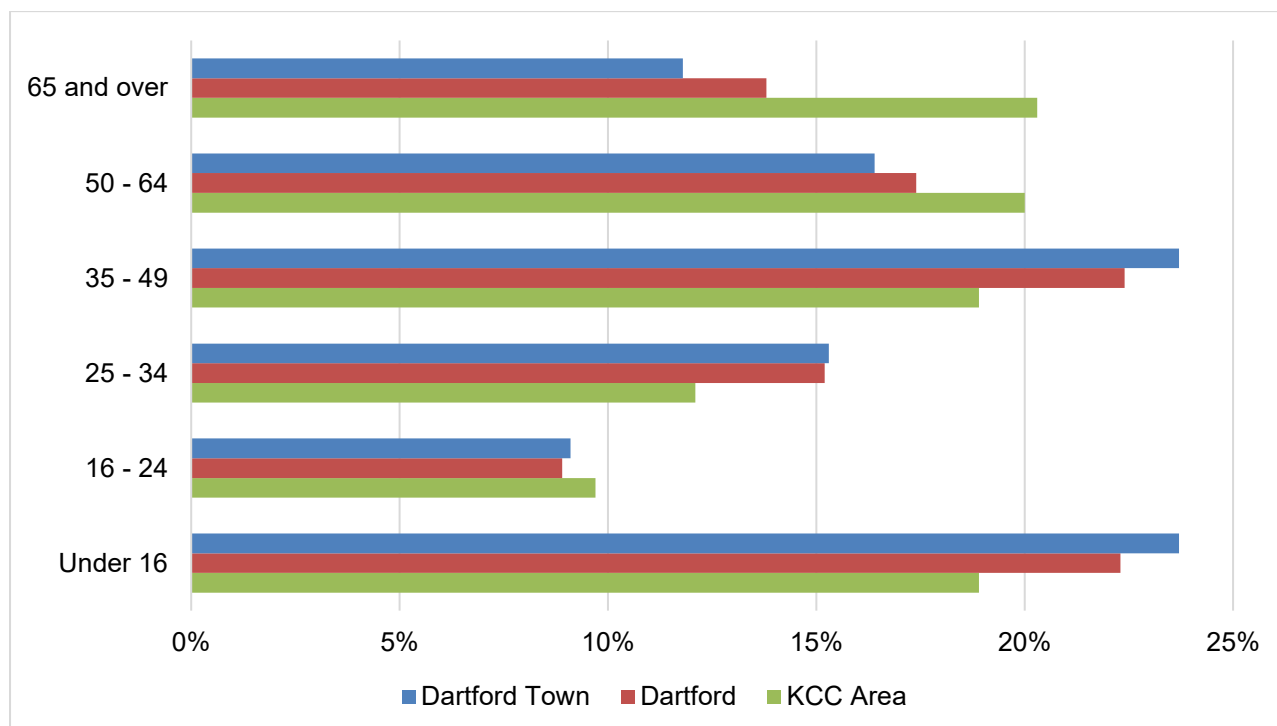

POPULATION DENSITY

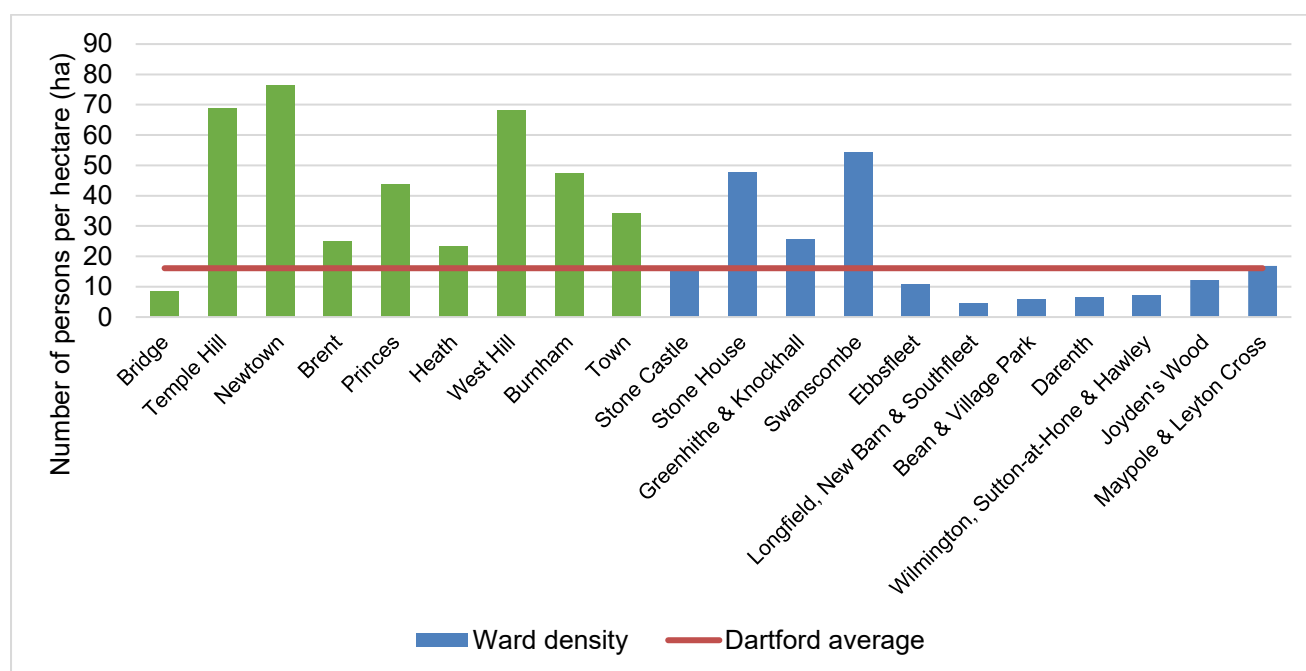
Dartford Town has a population density of 32.3 persons per hectare, compared to the Borough average of 16.1 persons per hectare.

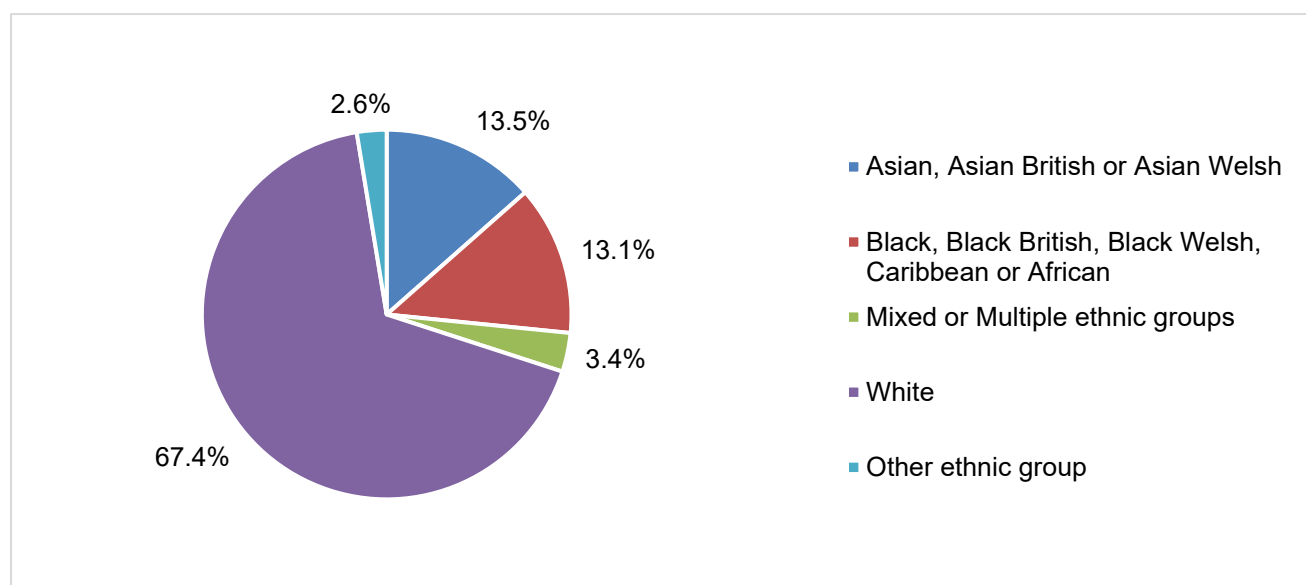

Chart 4: Population density by ward, 2021

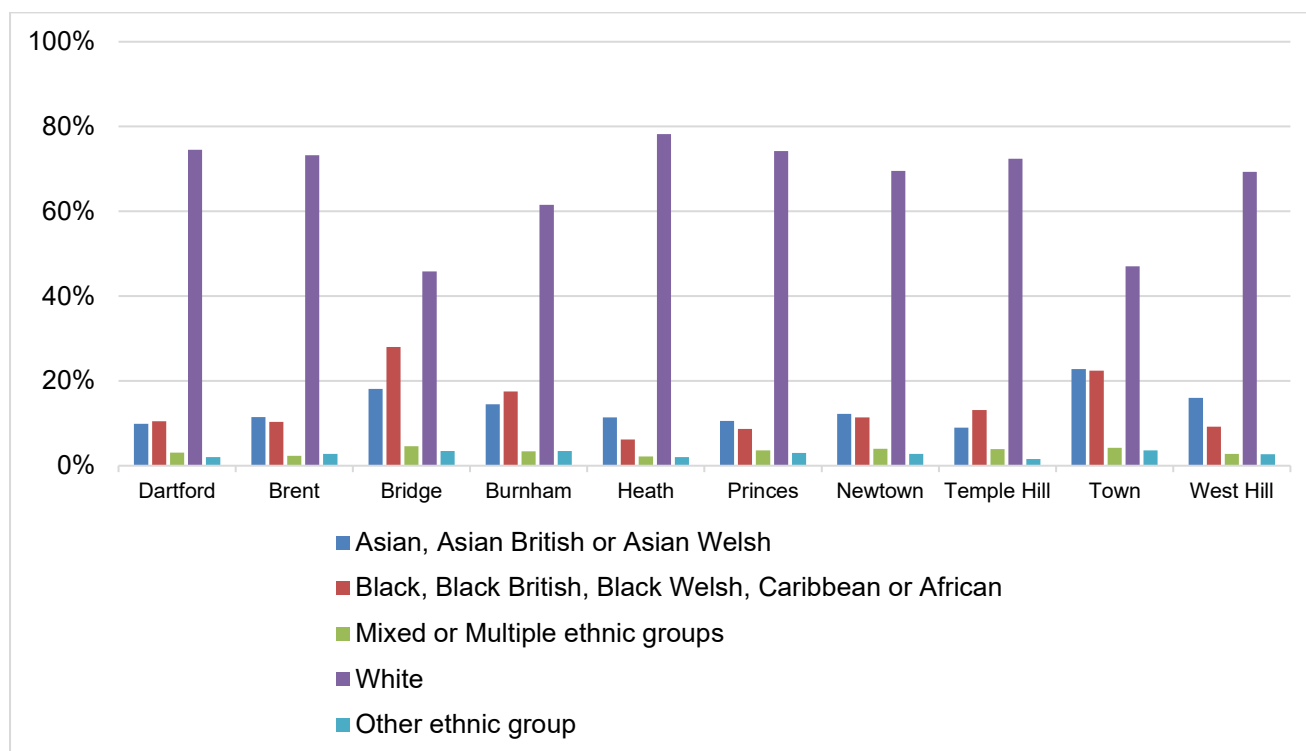

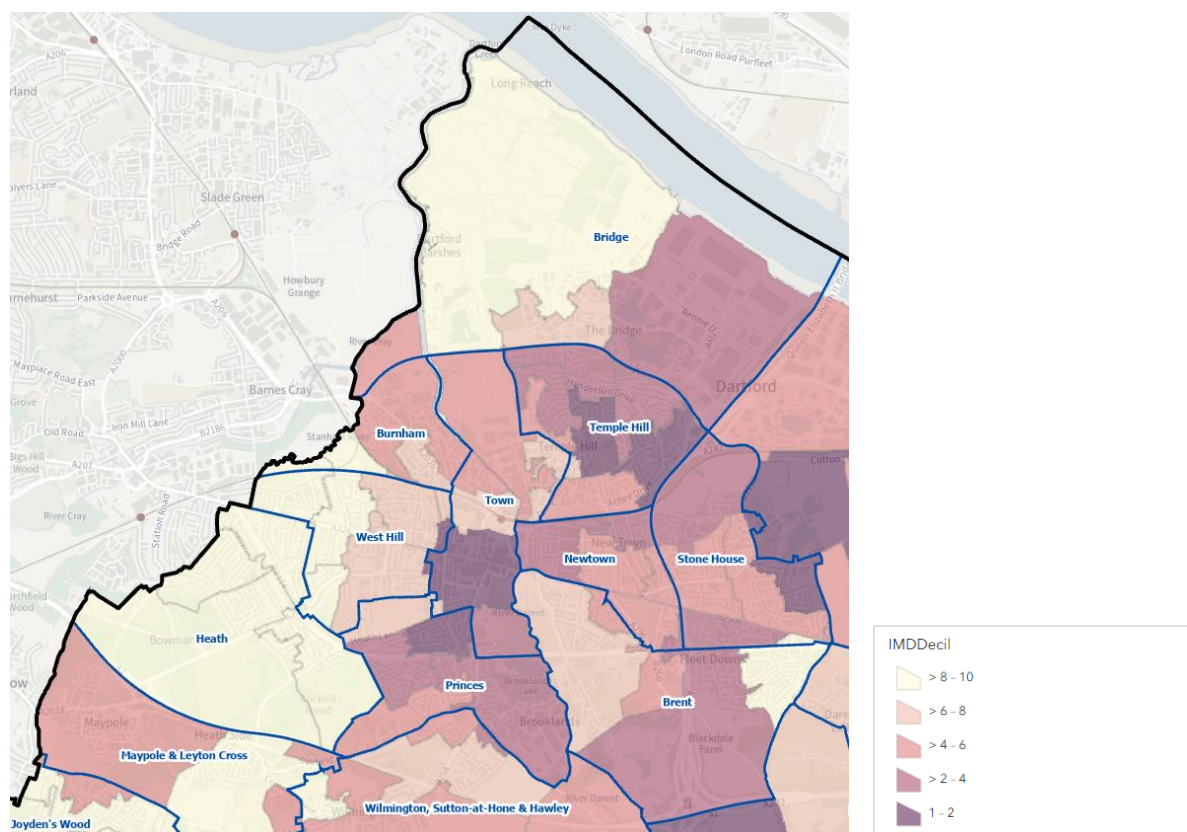
DEPRIVATION

The Indices of Multiple Deprivation (IMD) provides data to a localised scale in terms of the most and least deprived neighbourhoods. In 2025 the updated IMD was published, superseding the 2019 IMD.

Neighbourhoods are called a 'Lower-layer Super Output Area' (LSOA) and have an average population of 1,500 people. In Dartford, there are 67 such neighbourhoods and these do not align with electoral ward boundaries.

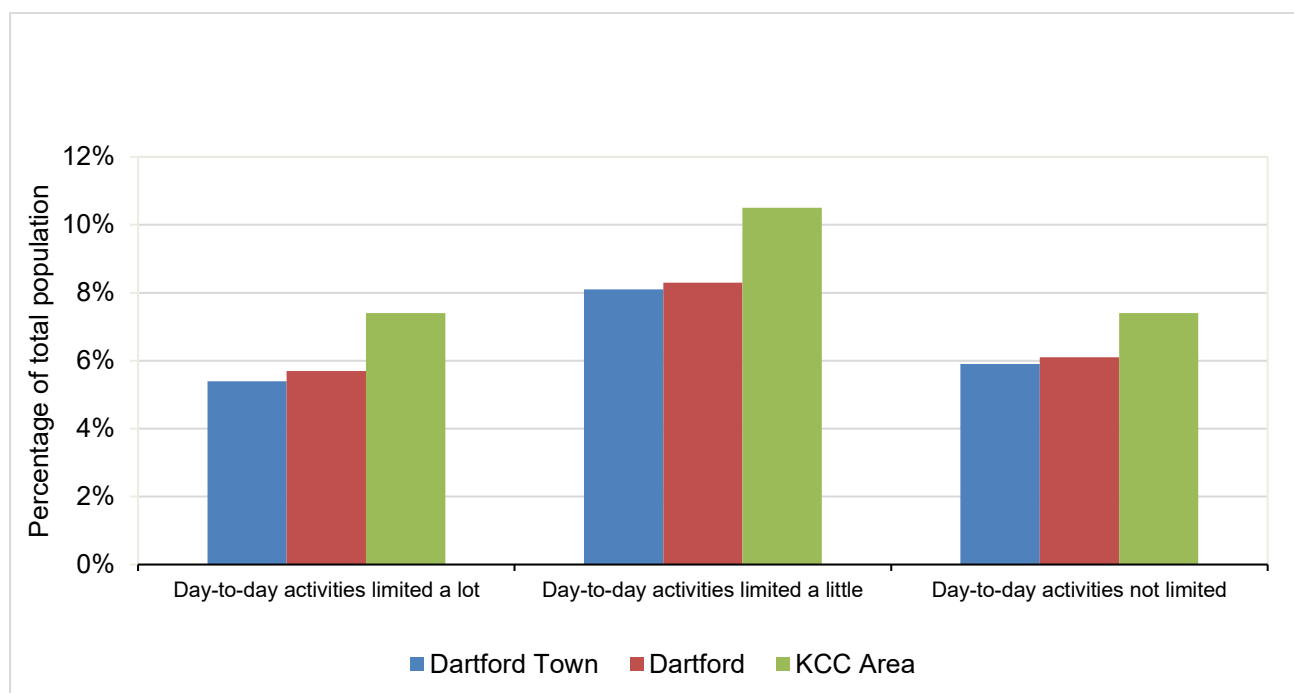
It is a mixed picture within Dartford Town, with the most deprived wards being Princes, Town and Temple Hill. There are pockets of significant deprivation at the granular level, for instance the LSOA Dartford 0011 in Temple Hill is more deprived than 94% of all English neighbourhoods.

Dartford Town makes up 46.2% of the total employee jobs in the Borough.

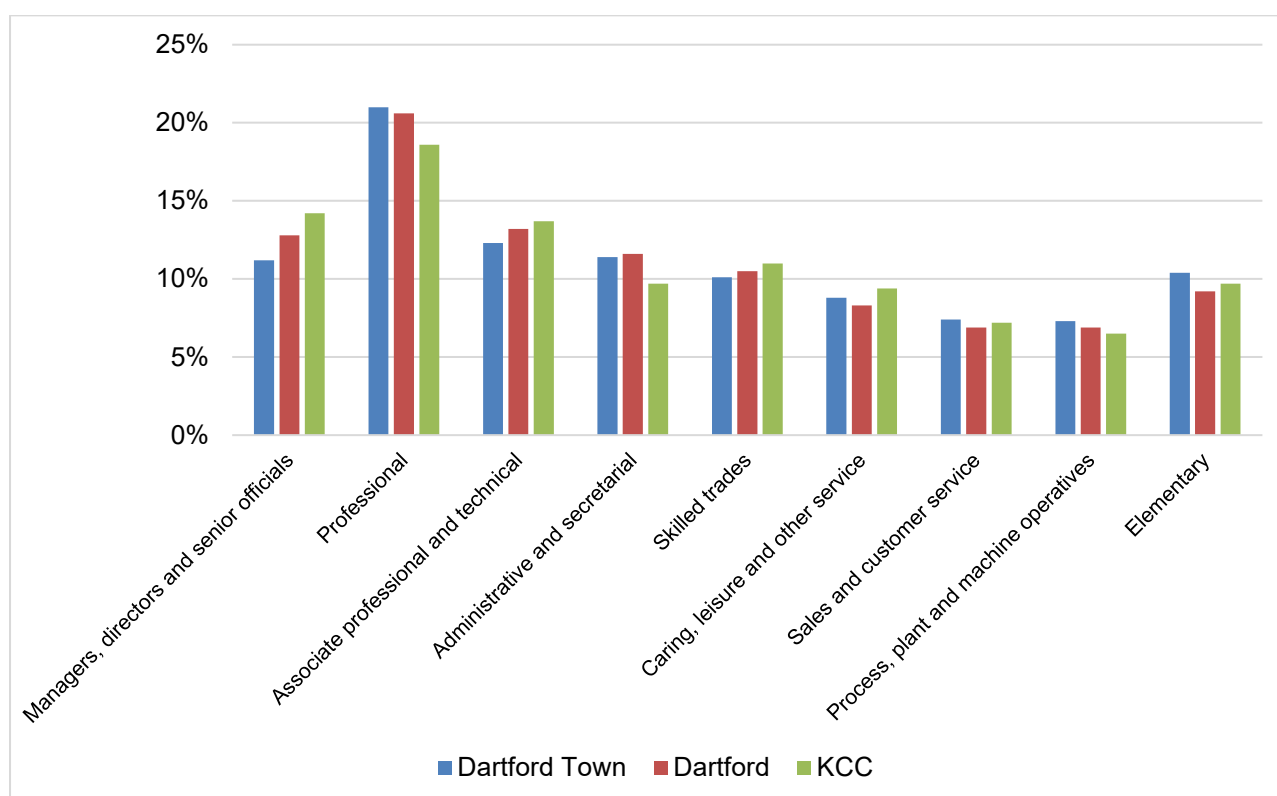

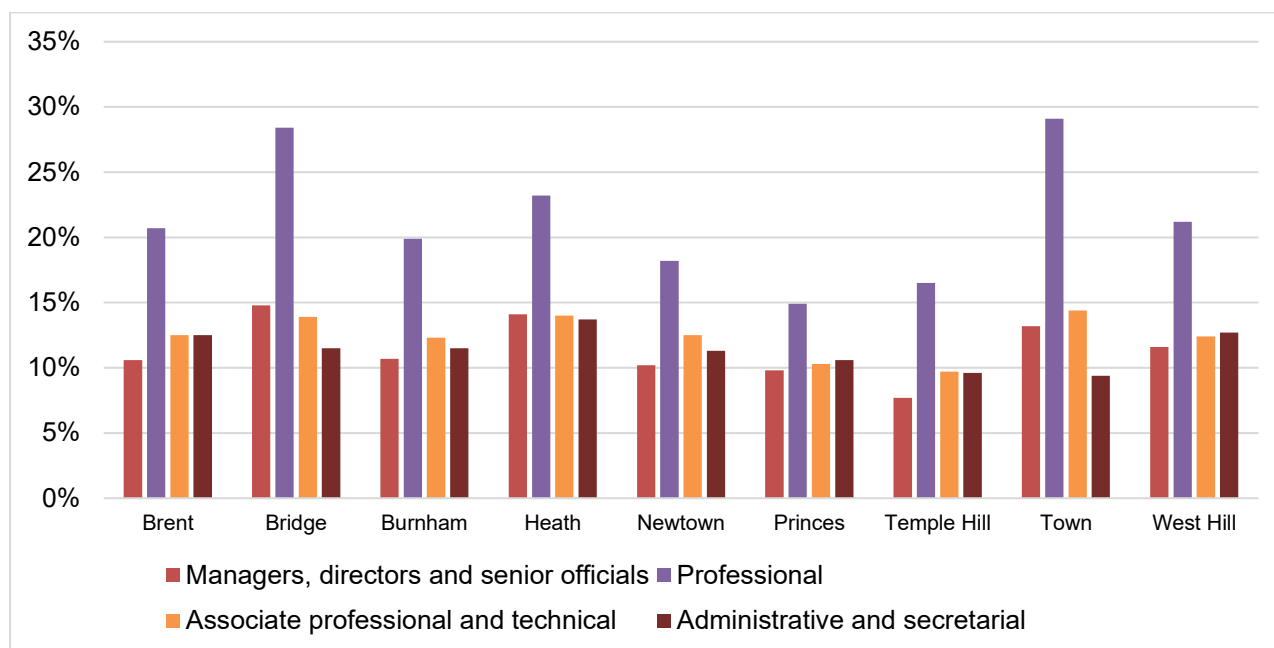

Chart 8: Percentage of residents (aged 16+) by employment occupation, 2021

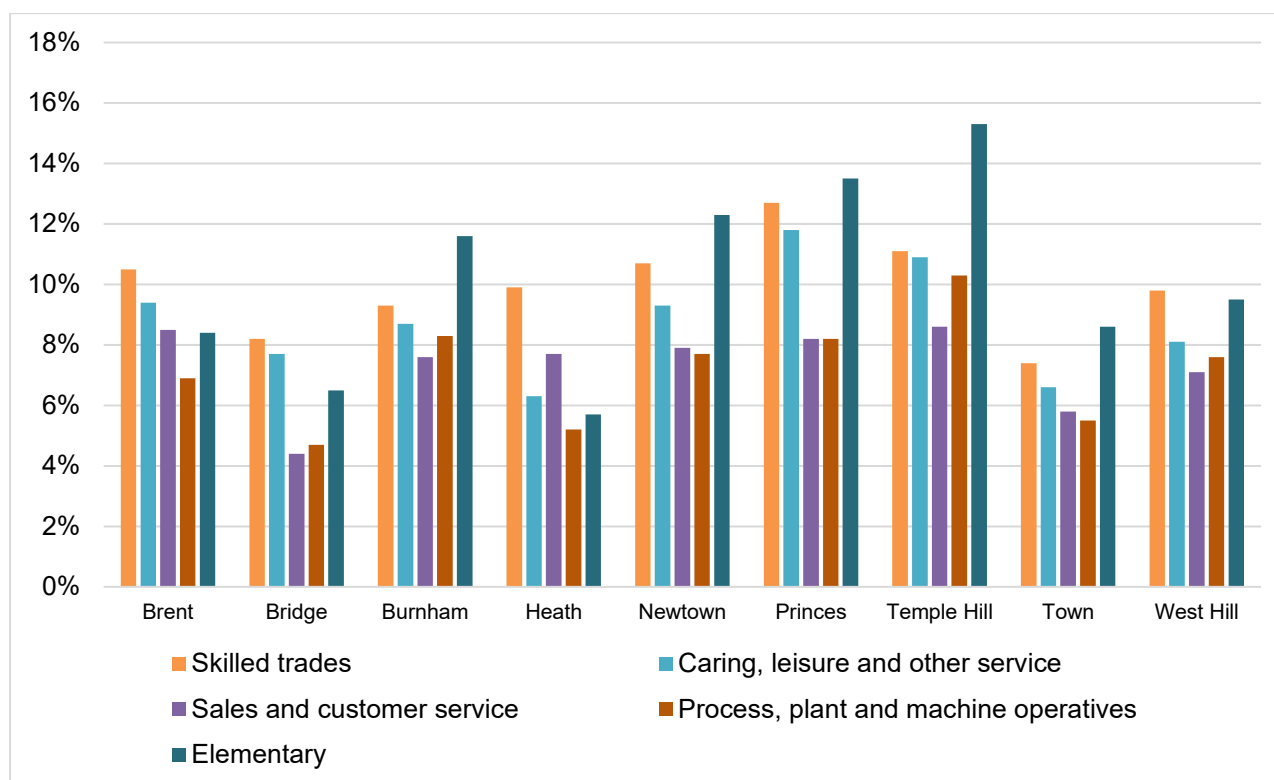

In all wards within Dartford Town, professional occupations are most common although the proportion differs substantially. In Bridge and Town, more than a quarter of residents undertake professional occupations. The proportion is much lower in wards such as Princes (14.9%) and Temple Hill (16.5%).

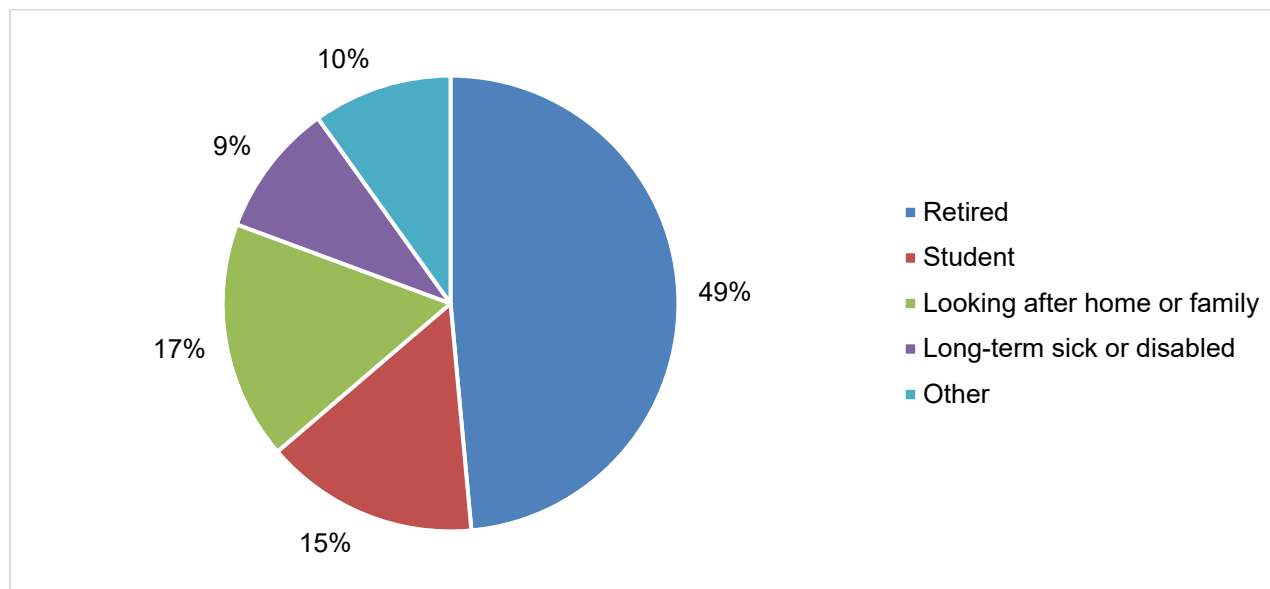
Chart 10: 'Blue collar'/service occupations by ward in Dartford Town, 2021

UNEMPLOYMENT

Of all usual residents aged 16 years and over in Dartford Town, 12,670 people (23.4%) were economically inactive in the 2021 Census. The reasons are shown below.

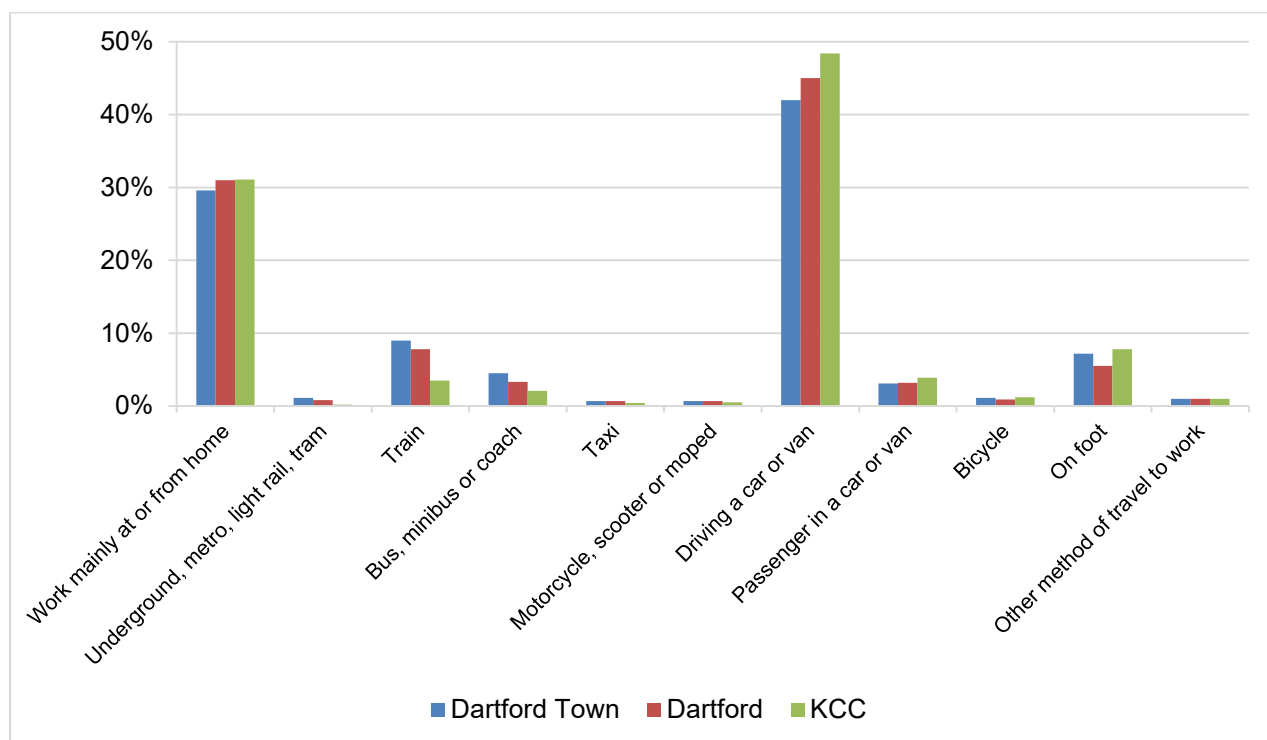

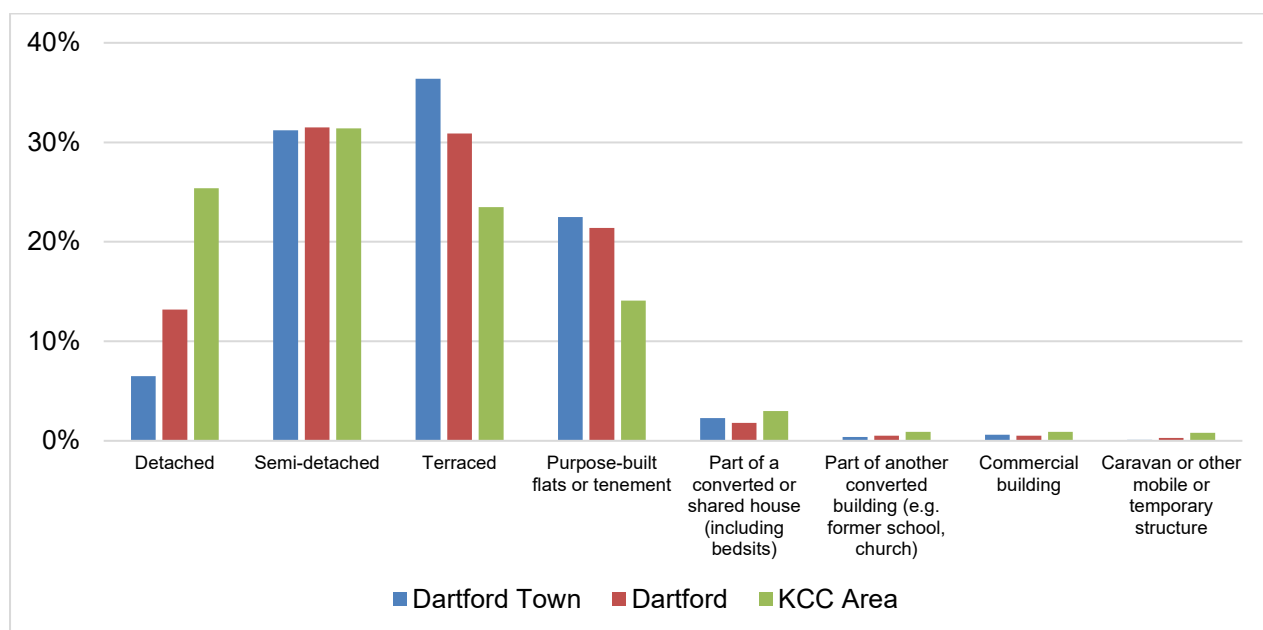
Chart 12: Method of travel to work, 2021

In 2021, there were 20,793 households in Dartford Town. The types of properties are shown below.

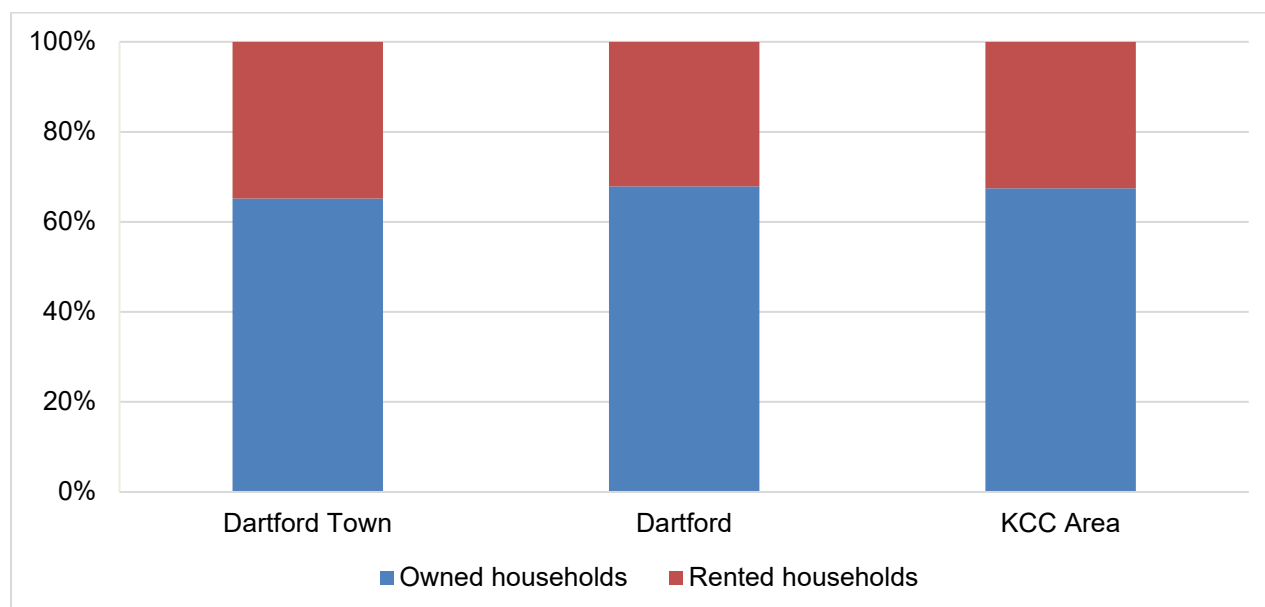
Chart 13: Types of housing, 2021

TENURE

65.2% of households in Dartford Town are owner occupied. Rented households consist of social rented and private rented or rent free.

HOUSEHOLD SIZE & OCCUPANCY RATING

8.4% of households in Dartford Town have fewer rooms than required, and 6.8% have fewer bedrooms than required. This implies that those households are overcrowded.

¹ Occupancy rating measures whether a household is overcrowded, ideally occupied or under-occupied. A rating of -1 or less indicates that a household has fewer rooms than required (overcrowded). The number of rooms is taken from Valuation Office Agency (VOA) administrative data.

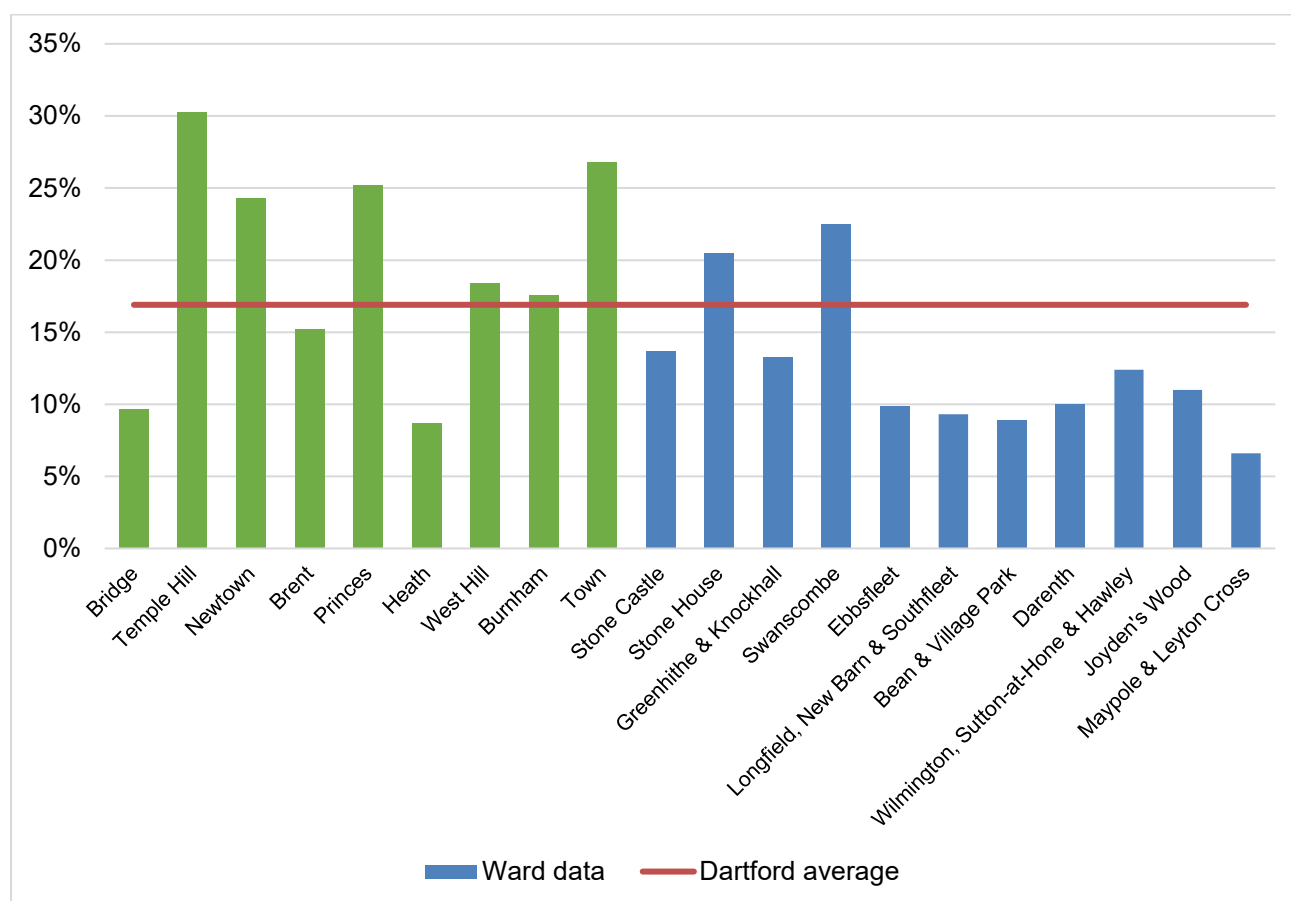

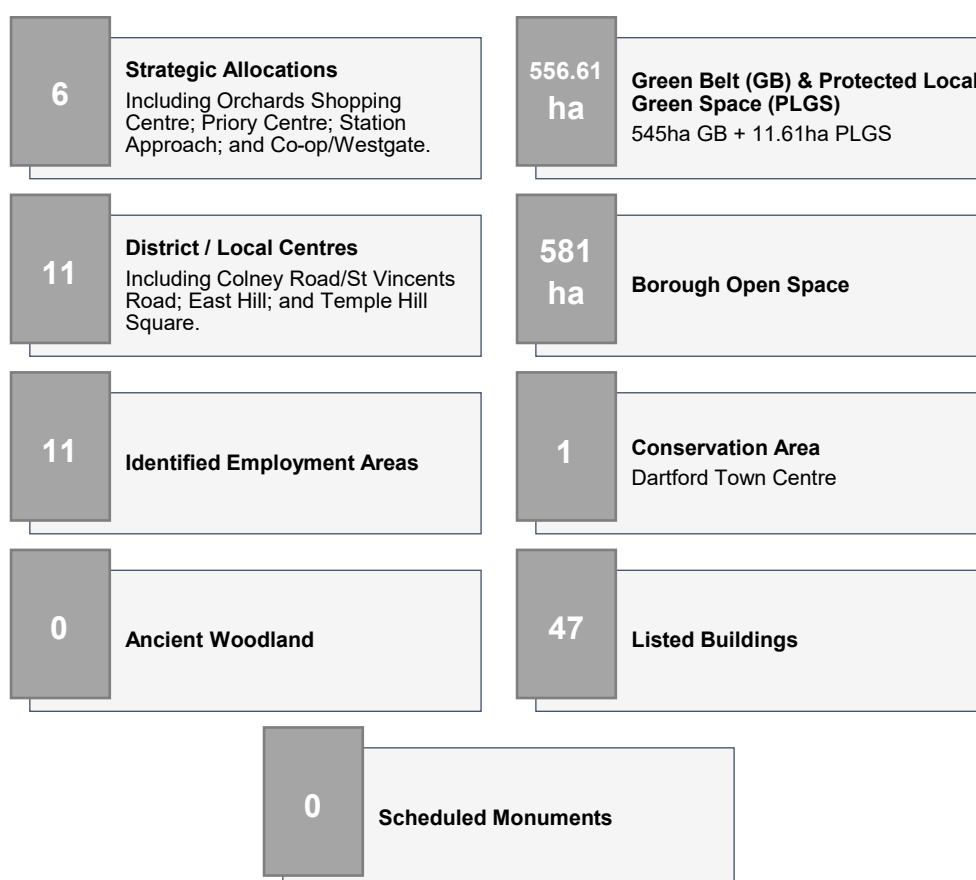
The chart below shows the various levels of car ownership in wards across the Borough against the Dartford average.

COMMUNITY INFRASTRUCTURE LEVY

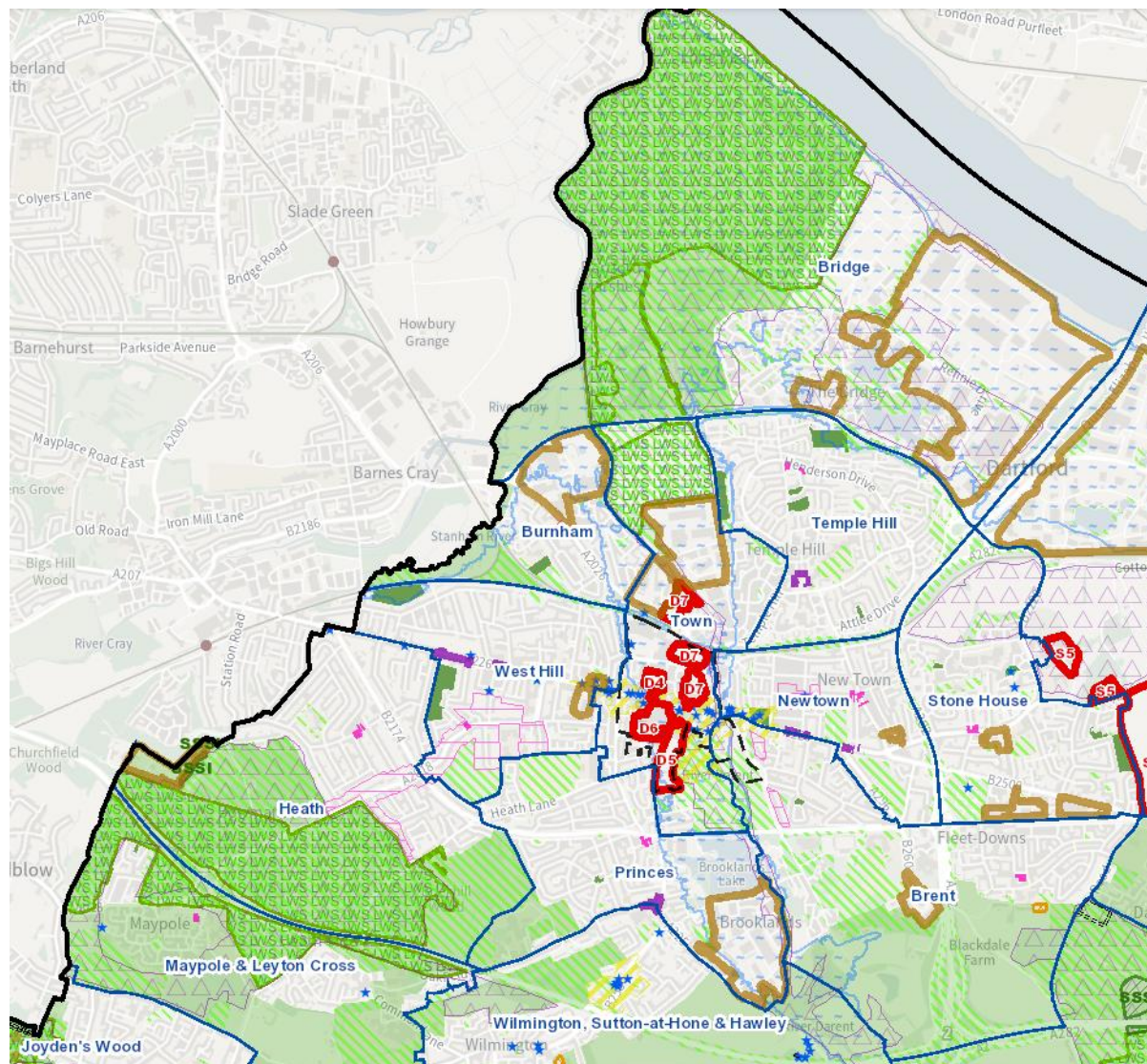
The Community Infrastructure Levy (CIL) is a charge on development that allows Dartford Borough Council to raise and pool contributions from developers towards the funding of a wide range of infrastructure. The Council introduced its CIL charging scheme on 1 April 2014.

A limited (nationally set) portion of Dartford's CIL receipts are transferred towards the local neighbourhood level, for appropriate smaller projects. In the unparished areas of the Borough 15% of CIL receipts are retained for neighbourhood spending.

In 2024/25, total CIL receipts amounting to £133,109 were retained by Dartford Borough Council for the unparished areas in the northwest of the Borough. The total amount of CIL funding retained in the 2023/24 financial year was £341,983.94.
