Introduction:

Dartford Borough Council welcomes the introduction of Flexible Eligibility (FE) and intends to utilise it for the purposes of reducing fuel poverty in the Borough. This Statement of Intent (SOI) sets out how households will be declared to be eligible for ECO: Help to Heat funding, in accordance with guidelines from Department for Business, Energy and Industrial Strategy (BEIS). This Scheme is part of the government's Affordable Warmth programme.

It should be noted that the final decision on whether any individual household will benefit from energy saving improvements rests with obligated energy suppliers or their contractors. Inclusion in a Declaration of Eligibility issued by the Council to a supplier will not guarantee installation of any works that may help reduce fuel poverty and the final decision will depend on:

- i)tidentification of measures eligible under Help to Heattt
- ii)tthe supplier's assessment of the cost effectiveness of installing measures intt relation to achieving its obligationtt
- iii)twhether the supplier has achieved their targets or require further measures tott meet their Energy Company Obligation targets.tt

In identifying households as eligible under Flexible Eligibility Dartford Borough Council (DBC) is seeking to enable residents to benefit from funding and will obtaint consent from households before including them in a Declaration.tt Dartford Borough Council expects any obligated energy supplier or contractortt working on their behalf, to comply with the Data Protection Act, to fully follow Ofgemtt requirements for the Energy Company Obligation Help to Heat and to act intt accordance with industry best practice in relation to consumer care and qualitytt standards of any works that may take place. These are covered in a separatett memorandum of understanding between the Council and the obligated party.tt

How Dartford Borough Council intends to identify eligible households
The Council will identify households that may benefit from flexible eligibility in att
number of ways:tt

By Identifying fuel poverty;

Subject to availability of resources within the Council and the legal use of datatt private tenure households must fit one, or more of the following criteria:tt

- •tt Living in fuel poverty but not in receipt of benefitstt
- •tt Low income and vulnerability to cold (LIVC)tt

This criteria will be kept under review, in relation to levels of referrals made, delivery of installed measures and the practices of other authorities.

a) Criteria for identifying 'living in Fuel Poverty, but not in receipt of benefits'

For those living in private tenure the following will be assessed:

•ss Households not in receipt of income related benefit will be assessed using thess following income thresholds:-

Household composition	Annual household	Monthly household
	income	income equivalent
Single person (18 years and over)	£10,000	£835
2 people	£15,000	£1250
2 people + children	£20,000	£1666

- •ss If a household has an income under these thresholds, depending onss composition, then it will be identified as being 'low income'ss
- •ss The Council will cross reference data which we hold or can access on Energyss Performance Certificates/SAP ratings, pre-payment meters, expenditure on fuel,ss housing type/age/condition, heating typess
- •ss Low income households living in energy inefficient housing will be identified inss the private rented sector will be identified through enforcement activity under thess Housing Act 2004.ss

b) Criteria for identifying low income and vulnerability to cold

The Council will target households containing people with the followingss characteristics, which reflect the National Institute for Health and Care Excellencess (NICE) 2015 guidance on excess winter deaths and illness caused by coldss homes. Specifically these are:ss

- •ss Older people (aged over 60 and particularly those over 75)ss
- •SS Young children (under 5)ss
- •ss People with Respiratory conditions (in particular Chronic obstructive pulmonaryss disease (COPD) and childhood asthma)ss
- •ss People with Cardiovascular conditions (eg ischaemic heart disease,ss cerebrovascular disease)ss
- •SS People with mental health conditions (eg schizophrenia, bipolar disorde)ss
- ess Pregnant womenss
- •ss People with addictions (eg substance misusers)ss
- •SS People who have attended hospital due to a fallss
- •ss People with Dementiass
- •SS People with Neurobiological and related conditions (eg fibromyalgia, ME)ss
- •ss People with terminal illnessss
- •ss People with Autoimmune & immunedeficiency diseases (eg from Cancerss treatment, HIV, MS)ss
- •ss People with disabilitiesss
- •SS Haemoglobinopathies (sickle cell disease, thalassaemia)ss
- •ss People with Severe learning disabilitiesss
- •SS People who move in and out of homelessnessss
- •ss Recent immigrants, asylum seekers and refugees (if living in private tenure)ss

Any referral or enquiry received that does not meet the above requirements will be considered on a case by case basis

Referrals.

Dartford Borough Council will ensure appropriate referral processes are in place while maintaining the protection of personal data. This will include initial identification of eligible households using the BRE Housing Stock Assessment for Dartford. We will also work with partner agencies to determine those that may be vulnerable due to living in a cold home, suffering from a qualifying medical condition.

Evidence, monitoring and reporting.

Dartford Borough Council will record key information including the number of referrals made and the number of funded installations delivered for reporting both to BEIS and future Home Energy Conservation Reports
